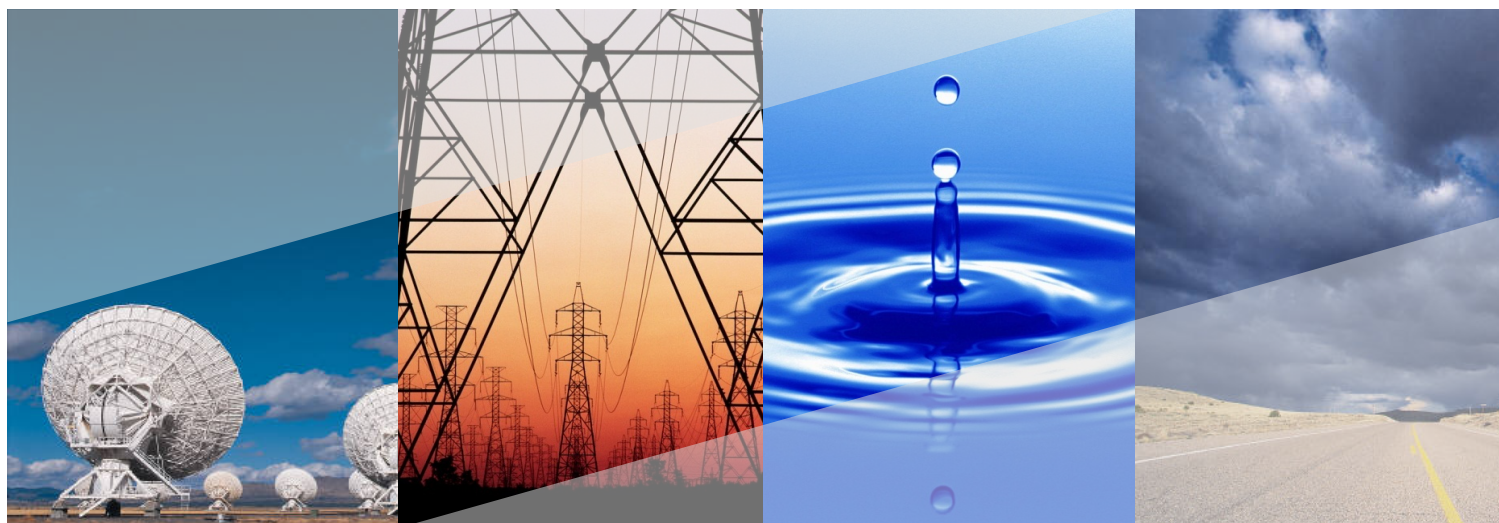

## ICA in brief

**Mission:** The Infrastructure Consortium for Africa (ICA) was launched in 2006 following the G8 Gleneagles Summit. ICA is a major initiative to accelerate progress in meeting the infrastructure needs of Africa in support of economic growth and sustainable development. ICA is not a financing agency, but acts as a platform to broker increased financing of infrastructure.

**Members:** Current ICA members include G8 countries (Canada, France, Germany, Italy, Japan, Russia, United Kingdom, United States), the Republic of South Africa, and Multilateral Institutions (African Development Bank, European Commission, European Investment Bank, Development Bank of Southern Africa, and World Bank Group). Membership of the ICA is open to other donors and partners making a significant contribution to infrastructure development in Africa, including other G20 countries.
