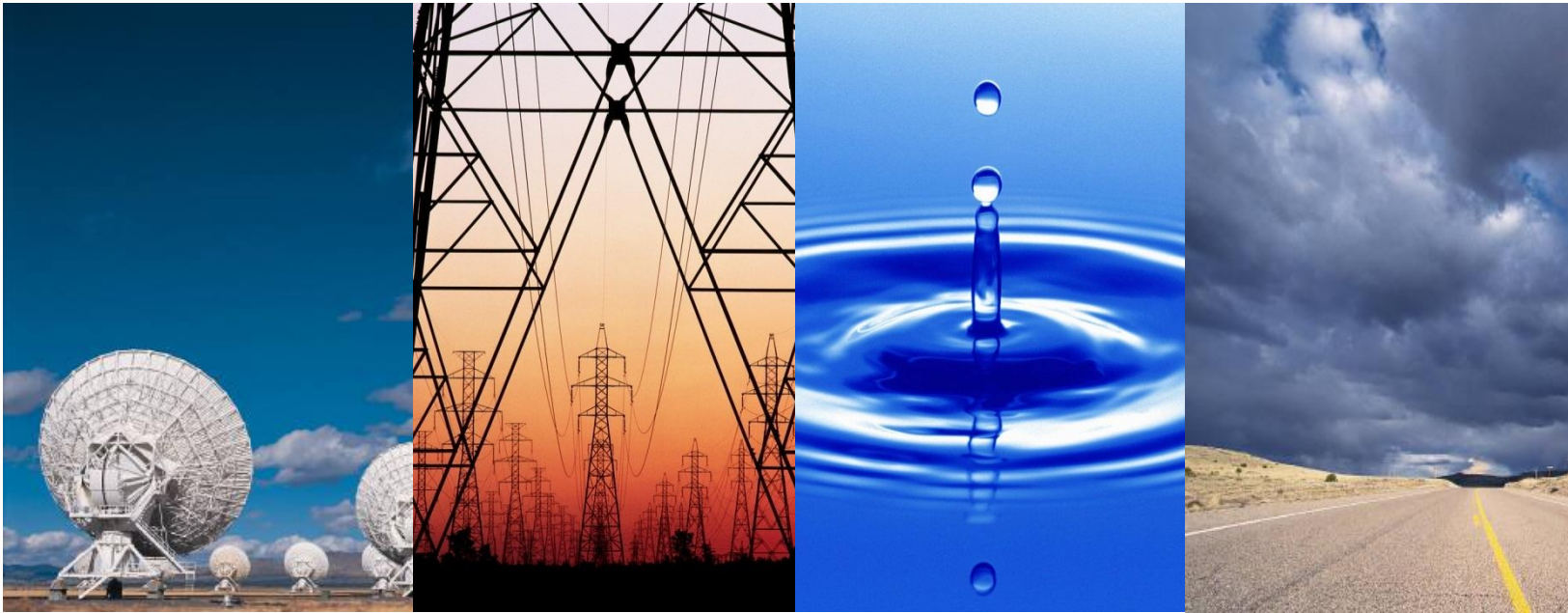

## ORIGIN OF ICA EXPANSION

---

- ❑ ICA - 5 years in Operation
- ❑ Evaluation of ICA conducted in March 2009
- ❑ Implementation of Strategic Business Plan 2010–2012
- ❑ Expansion from G8 to G20 - decision made at ICA Annual Meeting in May 2011
- ❑ G20 Development Working Group welcomed decision
- ❑ ICA Expansion to G20 - one major outcome of G20 Summit on 4 November 2011

## RATIONALE FOR EXPANSION

---

- ❑ Recognized need to coordinate efforts of all stakeholders to meet financing needs for African Infrastructure - estimated at US\$93 billion per year
- ❑ Acknowledgment of substantial contribution of G20 countries (i.e. China & India) in financing infrastructure in Africa
- ❑ Coordination of G20 Action Plan for Development - infrastructure Pillar

## EXPANSION FOLLOW-UP BY ICA SECRETARIAT

---

- ❑ ICA invitation letters sent August 2011 to first group of eight countries -  
Australia, Brazil, China, India, Saudi Arabia, South Africa, South Korea and Turkey
  
  - ❑ Four Potential Members requested clarification on specific issues -  
Brazil, India, Korea and South Africa
  
  - ❑ All 12 non-ICA member countries of G20 invited to participate as observers in ICA Members' Meeting - November 2011.
  
  - ❑ Internal consultations are under process

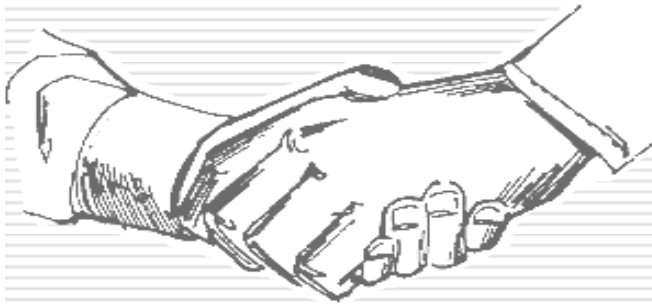

---

- ❑ Member States to support ICA Secretariat in promoting expansion

- ❑ Launch joint missions of ICA and member states to visit key potential countries by first quarter of 2012
- ❑ Conclude negotiations with new ICA members to allow their input in key documents for 2012:
  - ✓ Revision of Operational Procedures
  - ✓ Plan for 2nd Strategic Business Plan
