□ TICAD Ministerial Follow-up Meeting in May 2012

 Official announcement to hold the TICAD V at YOKOHAMA on June1-3, 2013

□ Keys for TICAD V

- Renewed emphasis on boosting economic growth
- Emphasis on the importance of creating an enabling environment where the private sector can play a greater role as an engine for growth
- Importance of Africa's infrastructure development strategies, including the Program for Infrastructure Development in Africa (PIDA)
- Need to promote infrastructure development through Public Private Partnership (PPP) and formulate bankable PPP projects



Regional Infrastructure Development and JICA ~The Enhanced Private Sector Assistance (EPSA)~

- At the Gleneagles Summit in 2005, EPSA was announced and pledged by the Government of Japan (GOJ), providing total of US 1 billion over the five years (up to 2010)
- The Government of Japan announced its intention to provide another USD 1 billion over the next five years for the second phase of EPSA at the Bank's Annual Meeting in Arusha, Tanzania





Regional Infrastructure Development and JICA ~The Enhanced Private Sector Assistance (EPSA)~

- Achievements in Regional Infrastructure under the Accelerated Co-Financing Facility (ACFA) (USD 221.44 million)
  - Bamako-Dakar Corridor (Senegal/Mali)
  - Arusha-Namanga-Athi River Road (Kenya/Tanzania)
  - Bamenda-Enugu Corridor (Cameroon/Nigeria)
  - Nacala Corridor Phase 1 (Mozambique/Malawi)
  - Nile Equatorial Lakes Countries Interconnection (Brundi/ Rwanda/Uganda/ Kenya/DRC)

# Regional Workshop on Joint Border Posts (JBP) Project

#### □ <u>Achievements:</u>

- The JBP (OSBP) Source Book was introduced to members of public and private sectors in West Africa
- The knowledge based on the practical experiences on JBP was generated and shared
- Stakeholders of JBP projects are sensitized on transport facilitation in West Africa

#### Recommandations for future actions

- Both UEMOA and ECOWAS Commissions further make their efforts to mobilize resources for the construction and operation of JBPs
- Both UEMOA and ECOWAS Commission harmonized their legal frameworks related to JBPs implementation
- Member states take necessary measures for effective suppression of any type of impediment to intercommunity exchanges to ensure a sound operating of JBPs.

  - SADC Secretariat is now taking the SADC Regional Workshop held in October 2011 by drafting the OSBP strategy and is expected to finalize and present the same to a stakeholder meeting.
- The second phase of the Southern Africa Integrated Regional Transport Program
  - Consulting firm under procurement
- □ Kazungula Bridge Construction Project (Zambia/Botswana)
  - Zambia 2,877/Botswana 8,735 JPY million
  - Co-finance project with the AfDB under the EPSA 2
  - Pledged in February 2012
